No employee will be favored, disadvantaged, or retaliated against based on his or her contribution amount or his or her decision not to contribute. No form of coercion may be used to solicit contributions. A suggested contribution is just that, a suggestion. Funds donated to NBA Federal BankPAC support candidates for a Federal office who support the banking industry.
